Respective responsibilities of the body and the auditor

Our responsibility is to review the annual return in accordance with guidance issued by the National Audit Office (NAO) on behalf of the Comptroller and Auditor General (see note below). Our work does not constitute an audit carried out in accordance with International Standards on Auditing (UK & Ireland) and does not provide the same level of assurance that such an audit would do.

External auditor report (ACHU0179)

On the basis of our review of the annual return, in our opinion the information in the annual return is in accordance with proper practices and no matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

Other matters not affecting our opinion which we draw to the attention of the smaller authority:

We note that the smaller authority did not comply with Regulation 15 of the Accounts and Audit Regulations 2015 as it failed to make proper provision during the year 2016/17 for the exercise of public rights, since the period for the exercise of public rights was less than 30 consecutive working days in length. As a result, the smaller authority must answer 'No' to Assertion 4 of the Annual Governance Statement for 2016/17 and ensure that it makes proper provision for the exercise of public rights during 2017/18.

The smaller authority has not provided an adequate explanation for the 'No' comment on statement H of the Annual Internal Audit Report and details of the action being taken to address the weakness identified.

The smaller authority has not provided an adequate explanation for the 'Not Covered' comment on statements C, D and G of the Annual Internal Audit Report, including either the most recent internal audit work completed on this area and when work is next planned or why coverage is not required by internal audit.
